PROBLEM

Their application developers and data users struggle to identify the correct data sources for critical business processes, such as vendor banking details and unpaid invoice amounts. Additionally, the lack of a comprehensive data catalogue with quality ratings hinders the analytics team's ability to conduct meaningful analysis for efficiency and cost improvements.

To address these issues, exposé implemented a solution that provides clear visibility, supports accurate data classification and authorisation, and enhances the overall analytics capability by ensuring data is discoverable, comprehensible, and trusted.

SOLUTION
